"This is a soft and cuddly and warm project. It's really delightful," said Peter Hargraves of Sputnik Architecture, one of the organizers of the annual competition, at Friday's announcement.

Notice: Moving Forward with Amendment 17 to the Energy Efficiency Regulations

This is to inform you that Amendment 17 to Canada's Energy Efficiency Regulations has been published in the Canada Gazette, Part II. This is a significant milestone for Natural Resources Canada's continued work under its Forward Regulatory Plan 2022-24.

The Regulations Amending the Energy Efficiency Regulations, 2016, have been published, along with a Regulatory Impact Analysis Statement. The Amendment will come into force six months after the date of publication in the Canada Gazette, Part II, except for the requirements for central air conditioners and central heat pumps which came into force upon publication in the Canada Gazette, Part II.
